Open Agenda

1.0 Welcome and apologies

The hui opened with karakia from Fionna Moyer.

Lithgow (left at 10:03am during item 6.1) and F. Beals (left at 10:26am at the end of item 7.0) for early departure.

2.1 Te Poari Akoranga membership and meeting schedule calendar 2023

2.3 Open minutes of August 2023 hui

2.5.1 Delegations Memo

It was noted that:

- there was correspondence related to the Academic Quality Forum and how
 delegations have been interpreted. M. Gibbons advised that once organisation
 structure was in place, then it would become the delegation of the regional academic
 committees.
- granting of formal awards had caused some confusion and stress. This would be worked through to ensure the process was clearly understood.

2.6 Work plan

The workplan needs to be in place for 2024 and ensure that evaluative reports are coming to Te Poari Akoranga. Gaps have been identified in reporting, so need to process in place to ensure reporting includes Te Poari.

3.1 Type 1 Changes to Level 4 programmes

It was clarified that these approvals were for unified programmes and noted that once the academic committees were in place, these types of approvals would be managed by them. There was still work to do to ensure programmes were not missed in the approval process. Also future memos would go to Te Ohu Whakahaere Approval, and then brought to Te Poari Akoranga through the reporting process.

In response to a question was raised whether the unification team would get the memos as well, the designated business division that holds responsibility for processing Type 1 changes would receive them. Staff would work on getting clear communications out on that process.

Te Poari Akoranga supported the approvals to the Type 1 Changes to:

- New Zealand Certificate in Adult and Tertiary Teaching to extend the range of delivery weeks/hours to allow for the part time delivery undertaken by Learning Works
- New Zealand Certificate in Hairdressing (Professional Stylist) Level 4 add the following two delivery sites - 6008 Te Pūkenga TA Wellington Institute of Technology and 6014 Te Pūkenga TA Whitireia Community College.

- New Zealand Certificate in Business (Administration and Technology) (Level 4) to add the following two delivery sites omitted from the delivery sites listed in the original application - 6006 Te Pükenga TA ARA Institute of Canterbury and 6022 Te Pükenga TA Open Polytechnic of New Zealand.
- New Zealand Certificate in Apiculture (Level 4) and New Zealand Certificate in Apiculture (Queen Bee Rearing) (Level 4) - to add the following delivery site - 6015 Te Pükenga TA Southern Institute of Technology.

4.0 Draft Reporting Template for Regional Academic Boards

This template should remove the requirement to provide minutes as a reporting method, which can provide too much detail for the purpose of reporting.

There were discussions regarding:

- reporting and how WBLs, as part of Regional Academic Committees, would be incorporated into the reporting process.

6.1 Te Ohu Whakahaere Quality

6.1.1 Akonga Rights and Responsibilities

F. Moyer spoke to the document, highlighting consultation with the network and Te Ohu Whakahaere Quality.

Discussion and guidance provided around:

- whether the expectations on kaimahi were achievable and safe, especially where kaimahi are involved in appeals or disciplinary processes.
- matters related to equity as Māori, Pacific and Disabled Learners were not well represented in the framework.

Based on the discussion, more work was required and would be brought back to the October hui.

6.2 Te Ohu Whakahaere Rangahau Māori, Research and Postgraduate

6.2.1 Terms of Reference

F. Beals spoke to the Terms of Reference, noting more about governance and away from operational. Advice was sought from Te Ohu Reo me Ngā Tikanga in relation to the title of the Ohu and it has been recommended that 'Māori' be removed, as rangahau already indicates kaupapa Māori based practice.

- Pacific membership to ensure equity is visible.
- Intellectual Property.
