Request under the Official Information Act 1982

Thank you for your email of 29 April 2025, requesting the following information from Te Pūkenga – New Zealand Institute of Skills and Technology (Te Pūkenga):

How many staff in FTE terms were employed in each Institute of Technology and Polytechnic division of Te Pūkenga, as at 31 December 2021 and 2022?

This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

The decision

We have interpreted your request to be a follow up query to the response provided by the Minister for Vocational Education, Hon Penny Simmonds, to your written parliamentary question reference 17221 (2025), which provided the same information for 2017-2020.

Therefore, for ease of reference we copied the table provided within that response and include the additional information for calendar years 2021 and 2022, as at 31 December each year.

We note the following regarding the table and the updates provided:

- We provide a figure for Tai Poutini Polytechnic for the calendar year 2019, which was previously missing.
- Rounding has occurred; no decimal places have been provided for consistency with the previous years.

In addition, please be aware these figures may differ slightly from those within Te Pūkenga 2024 Annual Report and details within our Annual Review questions for select committee, due to the different parameters used for extraction (ie. reporting period, employment type included - permanent, fixed term, part-time, full-time and/or causal kaimahi details).
