1. Purpose

1.1 The purpose of this policy is to ensure appropriate guided supervision for postgraduate ākonga rangahau and research.

2. Audience and scope

- 2.1. This policy applies to postgraduate ākonga and postgraduate supervisors/academic mentors.
- 2.2. This policy applies to postgraduate programmes that require rangahau or research outputs including but not limited to theses, dissertations, creative works, and professional practice projects and/or reports.

3. Principles

- 3.1 Ākonga who undertake rangahau or research obtain ethical approval if required.
- 3.2 Ākonga are entitled to experienced rangahau or research supervision/academic mentorship that supports them academically, culturally, and pastorally.
- 3.3 Ākonga who undertake postgraduate rangahau or research will engage with the consultation process developed by mana whenua during the development phase of their rangahau or research proposal if required.
- 3.4 Ākonga own the output and intellectual property arising from their rangahau or research except where noted in the Intellectual Property Framework (under development).

4. Responsibilities

5. Procedures

5.1 Postgraduate Ākonga

- a. Ākonga undertaking rangahau or research will be supported academically, culturally, and pastorally by at least one supervisor/academic mentor. For outputs of 90+ credits, ākonga will be assigned a Primary Supervisor/Academic Mentor and a Secondary Supervisor/Academic Mentor.
- b. Ākonga Māori undertaking rangahau or research will be supported by Māori academics if this is their preference and whenever practicable.
- c. Details of supervision/academic mentorship meetings will be negotiated between the supervisor/academic mentor and the ākonga and documented according to their agreed Supervision/Academic Mentorship Contract.
- d. Rangahau or research supervision/academic mentorship can take place kanohi ki te kanohi (face-to-face) or online/ at distance, in line with relevant programme approval.
- Ākonga must complete a rangahau or research proposal which is approved by the appropriate delegated authority to ensure the rangahau or research is ethically and procedurally sound.
- f. Ākonga will be supported to consult with mana whenua/ relevant local Māori organisations during the development of their rangahau or research proposal to a level agreed in negotiation with mana whenua.
- g. Ākonga undertaking rangahau or research will have access to resources to complete their rangahau or research including library resources, statistical advice, additional specialist software and subject matter expertise as required to support the progression of their rangahau or research.
- h. Requirements for submission and examination will be outlined in the Programme Document relevant to the programme of study.

5.2 Procedures for Postgraduate Supervisors/Academic Mentors:

- a. Supervisors/academic mentors will be appropriately qualified and have subject matter and/or methodological expertise aligned to the ākonga rangahau or research project.
- b. Supervisors/mentors will assist ākonga to identify their rangahau or research-related learning needs and provide information about resources available to ākonga.
- c. Supervisors/mentors will be provided with the appropriate supports to enable them to exercise their responsibilities as supervisors/mentors.
- d. External examiners will be appropriately qualified and remunerated.
- e. Requirements for submission and examination will be outlined in the Programme Document relevant to the ākonga programme of study.



5.3 Procedures for submission and dissemination of Master's thesis/explanatory document/dissertation:

- a. These procedures are to be read in conjunction with the specific programme requirements set out in programme documentation.
- b. Ākonga must include evidence of ethics approval (if relevant) in both their rangahau or research proposal and final thesis/explanatory document/dissertation.
- c. Ākonga must include a signed declaration in their final thesis/explanatory document/dissertation.
- d. Ākonga who use 3rd party copyrighted work in their final thesis/explanatory document/dissertation must produce evidence of permission to publish.
- e. Ākonga must sign a Consent Form to allow their final thesis/explanatory document/dissertation to be deposited in either a physical library or open access online repository.
